The above positions/posts are on temporary contract basis.

The Director & Appointing Authority has the right to accept/reject any application without assigning

*Age relaxation is admissible in respect of Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. Age, qualifications, etc., will be reckoned as on the last date of receipt of applications.

Upper age limit is relaxable up to 5 years in case of candidates belonging to SC/ST and 3 years in case of OBC category. The candidates should ensure that they belong to the OBC category while applying the project posts. OBC-Non Creamy Layer certificate in the prescribed Such candidates should produce a valid format during document verification that he/she does not belong to the creamy layer. The OBC certificate shall not be older than one year at the time of joining the post. In case of not complying with these stipulations, their

candidature or OBC reservation will not be entertained.

5) ** Candidates applying for EWS category posts must possess Income and Asset certificate to be Magistrate/Collector/Deputy District Magistrate/Additional District Commissioner/Additional Deputy Commissioner/1st Class stipendiary Magistrate / Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner as per the DoPT OM dated 31st January, 2019. Candidates who are not covered under the scheme of reservation for SC's, ST's and OBC's and whose family annual income below Rs.8 Lakhs are to be identified as EWS's for the benefit of EWS reservation.

- reason. 7) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.

8) Other allowances like CCA, LTC, Medical Claim and PF are not applicable.

10) The recruited project staff is eligible for leave as per project recruitment rules/guidelines and will have to give an undertaking before joining.

- 11) At the time of joining duty, the candidates should bring all original certificates of educational qualifications (from SSC onwards), Experience, Aadhaar Card, Community and PWD Certificate (if applicable) for availing age relaxation, passport size photograph along with one set of photocopies of the certificates duly attested (can be self attested) for verification.
