- 1. - 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. - 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Buyer Added Bid Specific ATC

#### **NIN-TENDER**

Tenders are invited on behalf of the Director, ICMR-NIN, Hyderabad, Ministry of Healthy & Family Welfare, Government of India from reputed, experienced, contractors/agencies with established experience and financial solvency to carry out Maintenance and Operation of Electrical Sub-stations, Transformer yar ds, Generators, AC Plants and Pump House at ICMR-NIN, Hyderabad.

#### Mandatory Certificates/documents to be uploaded (qualifying criteria):

Bidders are liable to be rejected if they don't upload any of the certificate / documents requir ed as mentioned below:

- i. The bidder should have the Grade "A" Electrical Licence.
- ii. The Office of the service provider must be located in **Hyderabad, Telangana State**. ( documentary evidence is mandatory and only below mentioned documents accepted for a ddress proof)
  - a. Valid rental agreement/lease agreement copy with last two years rental/lease p ayment proof/ Bank statement.
  - b. If the bidder owns the property: Last two years property tax receipts, electricity bills or water supply bills.
- iii. Certificate of registration under shop and Establishment Act issued by the Competent A uthority , should be submitted as documentary evidence in support of the geographical pre sence of bidder in Hyderabad, Telangana State.
- iv. The bidder/firm should be registered/ licensed manpower supplier firm with Labour Depa rtment of **Telangana State Government**.
- v. The agency should also be registered with appropriate authorities under **Employees Pr** ovident Fund and **Employees State Insurance Acts**. (Documentary proof)
- vi. The bidder must have a valid GST registration in the state of Telangana: GSTIN (Goods and Services Tax Identification Number).
- vii. <u>For Minimum Average Annual Turnover</u> of the bidder (for 3 years): Documentary evidence in the form of certificate Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant/ Cost Accountant indicating the turnover details for the relevant period.
- viii. Bidders must in writing provide Acceptance of the Additional Terms and condition (ATC) documents (Annexure-I).
- ix. Profit and loss statement for last three years certified by Charted Accountant.
- x. Bidder to note that there shall be no requirement of paying EMD against this tender. However, all bidders shall be required to mandatorily submit the Bid Security declaration in lieu of EMD as per the format attached. (**Annexure II**) of Buyer Uploaded ATC document.
- xi. Performance certificate from the clients for the service rendered by the bidder.

#### 1. Scope of work &contract:

- a) The period contract is 2 years. However the contract can be extended up to another one year based o n the performance and requirement.
- b) The contract work of "Maintenance" and operation of Electrical Substations, Transformer yards, Gener ators, A/C Plants and Pump House operation at ICMR-NIN shall have to be carried out as per tender sch

edule. Also, if any of unit/ areas is un-clean, they shall be cleaned by the contractor without any extra payment. Suitable manpower shall be provided at the premises as per the requirement of the work.

#### c) ELECTRICAL WORKS TO BE CARRIED OUT BY THE OUTSOURCING AGENCY/CONTRACTOR

- i) The Maintenance of 11KV, HT and 440V, LT Substations of ICMR-NIN consist of 1000 KVA tra nsformers - 2 No's, 400 KVA Transformers - 3 No's and 250 KVA - 1 No.
- ii) The Maintenance and operation of LT Power Control Panels 2 Units.
- iii) The operation of DG sets with AMF control panels in case of power failure (625 and 320 KVA Gensets).
- iv) Attending Emergency calls in the Office and Residential Quarters during non-working hours i ncluding holidays.
- v) Round the clock operation (3 shifts a day) on every day throughout the year for Electrical Su b-station.
- vi) Log books shall be maintained for all the equipment/panels parameter and the maintenance works carried out for all the items mentioned above.
- vii) Minor works have to be attended during after office hours and in holidays with the instructio ns Electrical i/c as and when required.
- viii) Repairs/Replacements of Electrical works at residential quarters after office hours including holidays, if required.
- ix) In case of any breakdowns, replacement of spares/parts/components for the Minor Electrical woks shall be carried out and required spares will be provided by the Institute.
- x) Filling of Diesel in Diesel tanks of Generators as and when required.
- xi) Follow up to the office of TSSPDCL in case of power supply failure / HT fuse off or any break down from incoming side.

#### d) A/C PLANT WORKS TO BE CARRIED OUT BY THE OUTSOURCING AGENCY/CONTRACTOR

- i) Operation and watch keeping of A/C plants, all AHUs, exhaust blowers, cooling towers and pumps from evening 1730 hrs to next day morning 0900 hrs on all working days and 24 hrs on Saturday, Sun days and holidays as per the instructions of A/C plant In-Charge.
- ii) Maintaining of log books of running A/c plant on hourly basis on all off-working hours as mentione d above.
- iii) Repair of minor electrical issues like electrical breakers and supply issues related to the A/C plant equipments on all off-working hours as mentioned above.
- iv) Maintaining of water levels in the cooling tower and compensating tanks on all off-working hours as mentioned above.

#### E) PUMP HOUSE WORKS TO BE CARRIED OUT BY THE OUTSOURCING AGENCY/CONTRACTOR

Pump house duties are required to be carried out in two shifts a day i.e., 0600hrs to 01400 hrs and 1400 hrs to 2200 hrs throughout the year as per instructions of Maintenance In-Charge. The detailed scopes of the work are as follows.

- i) Pumping of water from HMWS&SB reservoir to NIN Sumps time to time.
- ii) Pumping of water from NIN sump to overhead tank.
- iii) Supply of water to residential quarters as per timing.
- iv) Maintenance of pump house, handling of all water control valve, pumps and surrounding area.
- V) Maintaining of log books of pump house.

#### 2. Quantity and quality of service:

- a) The contractor/bidder shall appoint trained staff having good bearing and maintain high standard s of tour out, maintain adequate staff to ensure there is no hold up of any service of any reasons w hatsoever. Any deficient in the number of staff deployed will entail reduction of payment in the mo nthly bill. The successful contractor/bidder as soon as the agreement is signed shall submit the list of their workmen to be posted at this Institute along with bio-date consisting of their educational/t echnical qualifications and work experience certificates. As and when the change in the workmen will be Informed to the concerned authorities in advance (ICMR-NIN).
- b) It is normally understood and agreed between both the parties that ICMR-NIN will not be responsib le or be liable for any laws that are in force/ than may come into force from time to time in respect of the personnel engaged by the contractor and he will be solely responsible for the terms and con ditions of their service, safety, healthy, statutory requirement, etc.,
- c) The contractor / bidder should provide PF A/c number, ESI Card and Photo Identity Cards to the contract employees provided at ICMR-NIN, Hyderabad. This should be done immediately but not late r than one month from the date of signing the joint agreement for record purpose.
- d) The contractor/bidder shall give suitable dress, safety gadgets, monsoon gears, identity card to th e persons deployed at ICMR-NIN for identifying the staff by the security and other departmental personnel.
- e) The contract personnel engaged and working equipment brought by the contractor for the work s hall be recorded at the NIN Security Gate before entering into the premises and obtain necessary gate passes.
- f) The contractor/bidder may note that in case of the work being awarded to him, he has to produce police verification certificate for the employees to be deputed for the work inside the ICMR-NIN, Hy derabad.

#### 3. Manpower Deployment by contractor / bidder:

- a) "ONE" Electrical Engineer visit shall cross check the maintenance work being carried out once in a week and he will be available for emergency calls with residential phone facility. Electrical Enginee r shall attend to the site for any major electrical breakdowns, emergency situations.
- b) Electrician & Helper 24 X 7 in "THREE" Shifts for operation sub-station including providing weekly off i.e., 3 Technician (Skilled) ITI electrical + 3 helpers (unskilled) to operate the sub-station round the clock and take care of the A/c plant operation after office hours and during holidays.
- c) 02 No's Semi-Skilled members required for operation of Pump house for 2 shifts in a day as per th e timings mentioned above by providing weekly offs as per the labour norms. The operator should have minimum qualification of ITI in Plumbing/fitter/Electrical with two years experience in relevant field (pump operator) to take care of water pump's/ operating the pump house for filling the water in sump and pumping water to overhead tank and water supply to the office and staff quarters by maintaining the log book.

#### 4. Payment Terms:

- a) The contractor should pay to their personnel minimum wages from time to time including VDA as notified by the Office of the Chief Labour Commissioner(C), New Delhi, Government of India along with other statutory benefits like PF & ESI, Bonus etc., as per Govt. norms. Any breach of minimu m wage condition will be liable for termination of the contract and same would be dealt accordingly.
- b) The contractor / bidder shall submit bills after the completion of every calendar and normally pay ment will be released within 15 working days from the date of submission of bill, if the bills are complete and correct in all respect and in accordance with the terms and conditions of the contract.
- c) The contract/bidder should enclose the remittances like of proof like PF, ESI and other Govt. statu tory benefit for ICMR-NIN record.
- d) Once the monthly Bill payment is released by ICMR-NIN, Hyderabad, and this Institute do not have any responsible for the delay in payment of wages for their workmen.
- e) If the contractor fails to do any operation on any day in a month, then that cost per operation will be deducted from contractor's monthly bills.

f) No representation for the enhancement of the prices of the accepted tender or alteration of the terms and condition will be entertained till supplies/contract is completed.

#### 5. Tenure and Termination:

- a) The contract with ICMR-NIN, Hyderabad will be initially for a period of Two year and if the services are found to be satisfactory, the contract may be extended for further one year on the same terms and conditions. The institute reserves the right to terminate the Contract during the pendency of the contract period if the performance is found unsatisfactory.
- b) The contract could be terminated on either-side by giving one month notice in writing. Otherwise, the entire security/performance deposit/guarantee will be forfeited. Any other costs and / or dama ges incurred by the ICRM-NIN to maintain the services contract to the Contractor, on account of su ch short notice will be deducted from the dues payable to the Contractor, or shall be paid by the C ontractor on demand if such dues fall short of such costs.

#### 6. Performance Guarantee:

5% of the work order (i.e., 24 months cost) value in the bank guarantee is required to be furnished within 15 days from the date of issue of the work order. The same will be refunded on completion of the work con tract.

#### 7. Safety, Security and Insurance:

- a) The contractor/bidder shall follow the security rules of the ICMR-NIN and instructions received fro m the time to time regarding personnel identity cards, material movement etc., of the Contractor.
- b) During the pendency of the agreement, the contract/bidder shall be liable fully to compensate all concerned for any loss, damage of construction works / maintenance of plants and machinery, per son, property etc., including third party risks arising due to causes attributable to the agreement. The decision of the ICMR-NIN, Hyderabad will be final & will be binding on both parties. The contract or/bidder shall take Employees Liability insurance of prescribed value for their employees/ works under workmen compensation Act, 1928 as amended from time to time. Before starting the work, the Contractor shall produce the original insurance policy and the license of the workers to the Institute whenever applicable. The Institute is not responsible for any damages caused to the contract employees.
- **8. Dispute and Resolution:** Any dispute or difference that may arise between the partiers shall be ref erred to the sole arbitration of the ICMR-NIN or its nominees and the contractor/bidder shall have no rig ht to object the appointment of the Director or its nominee as the sole arbitrator. The arbitrator shall be final and binding on the parties. The venue for arbitration shall be Hyderabad and no other place. The provisions of the Arbitration conciliation act 1996 as amended from time to time shall apply. The courts in Hyderabad shall be exclusive jurisdiction to deal with any or all disputes between parties.

#### 9. GENERAL TEMRS AND CONDITIONS:

- 1. The work mentioned is only indicative. The ICMR-NIN reserves the right to increase or decrease the quantum of work. The contractor/bidder shall execute the work on the same terms and conditions a nd rates throughout the period of agreement.
- 2. The Contractor/bidder or his supervisor in the capacity of Engineer the field of Electrical/Air-conditio ning/plumbing shall meet the designated Officer(s) of the ICMR-NIN once in a week and in emergenc ies during holidays also and shall attend the site of any major breakdowns/emergencies. etc.
- 3. The bidder may visit the site with prior appointment of Sri P.C. Beshra (Electrical) at 040-27197246/288 and Mr. G Mahendra (AC) at 040-27197312/257, Mr. Y Nikhil Sagar (Plumbing) at 040-27197312 on all working days i.e., from Monday to Friday except public holidays from 10.00 a.m. to 5.00 p.m..
- 4. The undersigned reserves all the rights to reject the tender without assigning any reasons.
- 5. ICMR-NIN, Hyderabad is not responsible for any damage caused to the manpower personnel engage d by the contractor for execution of the work.

#### **Confidentiality Clause:**

- A. No party shall disclose any information to any third party concerning the matters under this contract. In particular, any information identified as "proprietary" in nature by disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior consultants, advisors or the employees engaged by a party with equal force.
- B. Prohibition against use of ICMR-NIN's name without permission for publicity purpose:-

The contractor/bidder, subcontractor, consultant, advisor or the employees of the contractor shall not use the ICMR-NIN's name for any publicity purpose through any public media like press, T.V., Radio or Internet without the prior written approval of ICMR-NIN.
