# Special terms and conditions-Version:1 effective from 15-02-2023 for category Autoclave (Horizontal)

- All Provisions of Drugs and Cosmetics Act, 1940 and Rules made there under as amended till date will always be applicable. This will include all notifications issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time in this regard.
  - 2. The sellers are registered on GeM based on self-declaration of valid Drug License, product certification, test reports etc. However, buyers must check and validate the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of drug license, product certification, manufacturer certification/licenses, test reports etc.
  - 3. In case of authorized resellers/distributors, it will be the responsibility of the manufacturer to ensure that their resellers/distributors are operating in compliance with all relevant laws and regulations and are properly licensed to sell the manufacturer's products, including verifying the validity and authenticity of drug license held by them. All legal & regulatory liability in respect of the offered/supplied product shall be totally of both manufacturer and reseller/distributor.
  - 4. The price offered by the seller/bidder shall not, in any case exceed the DPCO/NPPA controlled price or price fixed by State Government, if any. The seller must reduce the prices if there is any reduction in DPCO/NPPA ceiling price or price fixed by State Government, if any.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 8. Generic

#### 9. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 10. Turnover

#### 13. Warranty

Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide AMC Service for next 2 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into an AMC agreement (covering preventive maintenance and servicing) with the Successful Bidder / OEM after expiry of the Warranty period at rate as mentioned above and the payment for the AMC charges would be made Quarterly after rendering of the AMC Services of the relevant AMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the AMC contract when called upon by the buyer. The original Performance Security of contract will be returned only after submission and verification of AMC Performance Security for 10% of total AMC value valid up to AMC period plus 2 months (if there is no other claim). #### 14. Warranty

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. ### 15. Warranty

Tender Inviting Authority: This tender enquiry for procurement of 02 No. of Double Door Horizontal Autoclave (High Pressure, High Vacuum Steam Sterilizer) is being invited by the Director General, Indian Council of Medical Resear ch, Ansari Nagar, New Delhi to be supplied at ICMR-National Institute of Nutrition, Hyderabad.
- 2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the pe riod of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance sec urity before the deadline defined in the request for bids/request for proposals document, they will be suspended for the period of 1 year for bids/request for proposals document from being eligible to submit Bids/Proposals for contracts with ICMR.
- 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.
- 4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm th at submits either individually or, as a member of a joint venture, more than one bid will cause all t he proposals with the firms' participation to be disqualified.

Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods, final destination and the absence of heavy handling facilities at all points in transit
- (b) The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements strictly as per Technical Specifications, and in any subsequent instructions ordered by the Procurement agency.

Settlement of Disputes: (a) If any dispute or difference of any kind whatsoever shall arise between the Procureme nt agency and the Supplier in connection with or arising out of the Contract, the parties shall make every effort to r esolve amicably such dispute or difference by mutual consultation.
- (b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Procurement agency or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given.
- (c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in acc ordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delive ry of the Goods under the Contract. In the case of a dispute or difference arising between the Purchaser/Consignee and a domestic Supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director General ICMR.
- (d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follows.
- (i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties shall be English.
- (ii) The decision of the majority of arbitrators shall be final and binding upon parties.
- (iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the commercial courts, commercial division and commercial appellate division of High Courts (Amendment) Act 2018, No. 28 of 2018 Ch apter IIIA.
- (e) Settlement of Disputes: Notwithstanding any reference to arbitration herein, a. the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and The Procurement agency shall p ay the Supplier any monies due to the Supplier.
- 10. Consignee details (Place of Delivery, Installation, Commissioning) –ICMR-National Institute of Nutrition, Hyderab ad
- 11. Insurance: Unless otherwise instructed, the supplier shall make arrangements for insuring the goods against los s or damage incidental to manufacture or acquisition, transportation, storage and delivery in the following manner:
- (a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entire stores contract ed for arrival in good condition at destination. The transit risk in this respect shall be covered by the Supplier by get ting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.
- (b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be g ot extended by the supplier at their cost till the successful installation, testing, commissioning and handing over of t he goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the sit e to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be reimbursed.
- (c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favour of I ndian Council of Medical Research, covering all risks basis for the goods from supplier/ manufacturer warehouse to consignee warehouse.
- 12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) inco rporated in the contract, the purchaser/consignee shall, without prejudice to other rights and remedies available to

the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individ ually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc . a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maxim um of 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier.

- 13. GST will be applicable as per the latest GoI notification.
- 14. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment.
- 15. Following categories of Sellers are exempted from Years of Experience and Turnover:
- (a) Micro and Small Enterprises who are manufacturer of the Primary Product Category and give specific confirmation to this effect at the time of bid submission and whose credentials are validated online through Udyam Registration / Udyog Aadhaar (as validated by Government from time to time) and through uploaded supporting documents.
- (b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).
- 16. The manufacturer's authorisation must be insisted upon on a tender specific basis, not general authorisation/ de alership, by so declaring in the bid documents clearly. In cases where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorise only one agent/dealer.
- 17. Bidders need to indicate the percentage of local content and the component wise bifurcation of the local content. Bidder has inform the level of collaboration/ joint venture/ etc with the Indian firm with location of the offic e for manufacturing this goods in India as per Government of India Make in India (MII) norms/ policy.

#### 18. It is mandatory for the bidders to comply the following parameters of specification

#### **Technical Specifications:**

- 1. Chamber:
- Inner chamber size: Width: 4ft, Height: 4ft, Depth:6ft.
- $\bullet \ \ Design \ temperature : 100-150 ^{\circ} C.$
- Material: The chamber material should be made of AISI 316 Inbuilt steam generator, outer cover and flush mountin qs of AISI 304.
- Pure steam will be used in the chamber for sterilization purposes.
- 2. Jacket:
- Jacket's working pressure:1.2 to 2.0 Kg/sq.cm.
- Working temperature: 110-135°C.
- 3. High-pressure high vacuum (pre-vacuum and post-vacuum through suitable vacuum pump and SS condenser).
- 4. The stand should be of powder-coated steel.
- 5. The autoclave should have the inbuilt electrically operated steam generator of adequate capacity with sensors for automatic and safe operation.
- 6. Should have inbuilt auto-water feeding system including pump, automatic water level control, low and high-water level control, low and high-water level cut-off (both).
- 7. The doors should be a radial hinged double door with chamber interlocking and a temperature sensitivity locking s ystem should allow only one door to be opened at a time.
- 8. Should have end-to-end gastight bio-sealing between sterile and non-sterile areas.
- 9. Panelling should cover the entire autoclave including loading and unloading sides. Should be easily removable for inspection and service for repair and maintenance.
- 10. Should have a rapid cooling system. Air compressors of suitable capacity should be inbuilt.

- 11. A vacuum pump suitable for the capacity of a sterilizer should be maintenance-free and low noise level.
- 12. Computer connectivity port to be the part of equipment for remote viewing and controlling of sterilization cycle and data management of previous cycles and for service.
- 13. Necessary hardware (branded PC with printer) interface boards, cables & connectors, software along with licens es to be included.
- 14. The sterilizer should have automatic autoclaving cycle operations through a Programmable Logic Controller (PLC ). Should have online printing and backup facility for data storing and record keeping. The software should be part of the automation comprising of:
- Batch data storage for future reference.
- Process and parameters monitoring.
- · Alarm history
- Batch report trend printout (graphical report).
- Batch report excel export and formatted printouts.
- Real-time trends.
- Alarm diagnosis assistance.
- Fault analysis assistance for maintenance etc.
- The automation should be such that any error generated during the process should be displayed/ informed on-scre en and recorded in the print.
- All interruptions and failures must be indicated through audio-visual alarms.
- 15. When the door is not closed and sealed, the sterilization chamber should not get heated and the pressure in the sterilization chamber should not increase and also give an alarm.
- 16. The sealing hollow gasket for doors with a chamber should be of high-temperature resistance. When the sealing door on one side is closed, the sealing door on the other side can be opened, which ensures effective isolation.
- 17. When power is cut off, the valve should have a provision to be manually opened to release the pressure in the st erilization chamber.
- 18. Monitoring system of the autoclave must display the real-time monitoring of the equipment by the user to display and record the basic operating parameters of the equipment, time, temperature, pressure and other contents of different stages.
- 19. Under no circumstances should the operator or maintenance personnel be able to modify the permanent data.
- 20. The set program should display running time and remaining time.
- 21. The sterile air system should use a 0.2micron sterile filter to ensure no secondary contamination.
- 22. All essential and optional accessories like loading and unloading trolleys/carriages (minimum nos. per autoclave) including loading cabins to be quoted with the main offer.
- 23. Operating voltage: 415 V, 50Hz, three phase.
- 24. Total power/current consumption of the equipment should be mentioned.

#### Note:

- Manufacturing firms should either have certifications with latest version viz. ISO: 3829 (Part-I) with ISI mark, ISO 90 01 and ISO 13485 and CE mark or equivalent Indian Standards
- The supplier/bidders should visit the site to check the civil requirements for the installation and also mention any pre-installation and utility requirements for running the system.
- Hydrostatic, autoclave pressure test to be conducted on the chamber and the pressure jacket to meet safety regul ations.

Training during Installation& after commissioning of steriliser:

Training of operating personnel will have to be arranged by the manufacturer/supplier during the period of installati on and commissioning of the steriliser. Training should also be given on maintenance. This training is to be given thr ice a year during the warranty period.
